- 3. The in-service applicant has to forward his/her application form through proper channel.
- 4. In-service candidate if selected shall be on deputation for three (3) years as per SRO-75 dated 15-04-1993.
- 5. The non-service applicant shall be engaged on academic arrangement basis as per terms and conditions of S.O 364 dated: 27-11-2020.
- 6. The appointee shall be entitled the salary as applicable under S.O-364 dated 27-11-2020.
